- Prep their paperwork.
 - Once they've determined eligibility, gather supplemental documents to have ready for your application, including proof of citizenship and loan information verification.

The Health Center Resource Clearinghouse is looking for health centers and PCAs to join a dynamic learning collaborative!

Join a focused, four-session learning collaborative that will give you the background to use and access resources from the Clearinghouse and will help NACHC to improve the curation of their workforce materials. NACHC is looking to recruit larger health centers ideally with Chief Workforce Officers or similar role to review and provide feedback on proposed changes to workforce organization.

Participants will first learn to navigate the existing functionality of the Clearinghouse to understand the impact of the proposed changes. The results of a collaboration between NTTAP partners and PCAs will be the focus of the following three sessions. Participants will provide feedback on the viability/usability/applicability of these changes for their organizations, from taxonomy to promising practices. NACHC will also explore how best to highlight these resources to health centers to maximize their impact.
