## Capital Link Reports Demonstrate Value, Impact of Oregon CHCs During COVID-19

Earlier this year, OPCA began a project in cooperation with Capital Link to identify the impacts of COVID-19 on Oregon's community health centers and to demonstrate the overall value health centers bring to the communities they serve. The data is in! We are happy to share two statewide aggregated reports and the results of [Capital Link's COVID-19 analysis](#):

- The first report is a statewide [Value and Impact Report](#) which shows the impact health centers have on communities throughout Oregon.
- The second is an analysis of the [Financial Impact COVID-19](#) has had on Oregon CHCs.

In addition to the aggregated reports, Capital Link also created individualized reports for health centers. These will be available after OPCA Board Meeting on Nov. 20.

The first step to participation in the initiative is to complete an assessment of your health center's readiness to engage in health professions training programs.
