Community Health Centers Recognized for Excellence Across Oregon

Individuals or Teams at Four Community Health Centers Recognized for Their Contributions

Portland, OR (September 28th)– The Oregon Primary Care Association (OPCA) is pleased to announce the recipients for the 2021-2022 Awards of Excellence.

Every year, individuals and teams are nominated by their peers for outstanding work achieved in support of underserved and marginalized patients and communities in Oregon. A full description of the work these recipients do to improve access to healthcare, and how they positively impact their community can be found on our blog. Awardees were unveiled at OPCA's All Peer Group Gathering today.

More than 65% of patients seen in Community Health Centers (CHCs) identify as black, indigenous, or person of color (BIPOC) which is far greater than Oregon's general population comprised of less than a 28% BIPOC population, according to the 2021 census. CHCs work tirelessly toward health equity and innovations in healthcare delivery throughout communities across the state.

OPCA received 27 nominations and awarded six Annual Awards of Excellence honors and a Posthumous Award to:

Access and Sustainability Award Amber Webb & Yesenia Olvera, Community Health Workers Team, Neighborhood Health Center

Amber Webb and Yesenia Campuzano, from the Community Health Worker Team at <u>Neighborhood Health</u> <u>Center</u> were nominated for the Access & Sustainability Award for Ensuring Oregon CHCs are able to support ongoing and evolving needs for their services and communities.

About Oregon's CHCs

Oregon's community health centers deliver integrated medical, dental and behavioral health services to many of the state's most vulnerable communities through over 270 locations statewide. Over 450,000 Oregonians receive their care at a community health center, including one in six people on the Oregon Health Plan. Over 50% of patients live below the poverty line, and 71% live at or below 200% of the Federal Poverty Level. Over 75% of community health centers have clinic sites serving rural communities, 30% of Oregon's community health centers are federally recognized as Health Care for the Homeless locations, and 33% are designated as Migrant Health Centers.
